

FREMONT COUNTY COMMISSIONERS MEETING MINUTES
September 11 , 2023

Present for the meeting was: Commissioners Scott Kamachi, Blair Dance and Rick Hill

Commissioner Kamachi led the pledge.
Commissioner Dance offered the prayer.

Commissioner Kamachi called the meeting to order and welcomed those in attendance.

Assessor Carol Blanchard wasn't on today's agenda, but informed the Commissioners and the public the DMV will be closed the afternoon of September 19th, and closed all day the 20th and 21st for training in Boise. They will be open again on Friday the 22nd.

Treasurer Lori Beard RE: Tax Cancellations - action item

Ms. Beard presented the tax cancellations for the month of August 2023 in the amount of \$118.89.

Commissioner Dance made a motion to approve the tax cancellations for the month of August 2023 in the amount of \$118.89. Commissioner Kamachi seconded the motion. A full voice vote was heard with all commissioners voting in favor.

Elections Clerk Bonita Sutton RE: Designation of Polling Places - action item

Ms. Sutton presented a list of the polling locations for the upcoming November 7, 2023 election. They are the same locations as in previous elections. Several locations may be cancelled because we may not have races so elections won't be necessary. We do know there are races in the cities of St. Anthony, Parker, Ashton, and Island Park so we will have elections in those precincts.

GIS Greg Newkirk RE: Harames Parcel Amended Plat - 4th Amended Plat - action item

Clerk Abbie Mace RE: Presentation of Proposed Levies - action item

Clerk Mace presented the proposed levies for FY2023-2024. The City of Newdale and Road & Bridge were the only districts with an increase. Every other one went down. We are not levying for Special Road this year, and the Sugar-Salem school district is also not

levying. The Ambulance levy includes their supplemental levy increase this year, but the levy still went down.

Commissioner Hill made a motion to accept the preliminary tax levies for the 2023 tax year as presented.

Commissioner Kamachi seconded the motion. A full voice vote was heard with all commissioners voting in favor.

Noxious Weed Supervisor Bryce Fowler RE: Funding Agreement with Forest Service - action item

Mr. Fowler presented another participation agreement with the Forest Service in the amount of \$11,000.00. This is in addition to funds we have already received from the Forest Service and the RAC.

Commissioner Dance made a motion to approve the participation agreement between Fremont County and Caribou-Targhee National Forest in the amount of \$11,000.00.

Commissioner Hill seconded the motion. A full voice vote was heard with all commissioners voting in favor.

Payroll Clerk TaGenn Armstrong: Timesheets - action item

Commissioners reviewed the timesheets.
