

ORDINANCE #1978

ORDINANCE AMENDING FREMONT COUNTY COMMISSIONER'S
ORDER CREATING "NORTH FREMONT HOSPITAL DISTRICT"

4 WHEREAS, on the 2nd day of May, 1978, an election was duly held in the
5 Northern portion of Fremont County, Idaho, regarding the question of creation
6 of a Hospital District to be known as the North Fremont Hospital District.

7 AND WHEREAS, after a duly called election and vote thereon, the issue
8 of creating a hospital district within the area designated as the North
9 Fremont Hospital District, passed by a majority vote.

10 AND WHEREAS, an Order was passed May 8, 1978, creating North Fremont
11 Hospital District and excluded all lands owned by the United States Government
12 and State of Idaho.

13 AND FURTHER WHEREAS, it is practically impossible to describe each
14 and every parcel of land owned by the United States Government and State of
15 Idaho although such parcels cannot be taxed so long as they are owned by
16 the United States Government and State of Idaho.

17 IT IS HEREBY ORDERED, that the Order creating a hospital district in
18 Fremont County, Idaho, to be known as the "North Fremont Hospital District"
19 is amended to encompass and include the following described property:

20 Beginning at the Northeast corner of Section 5, Township 9
21 North, Range 45 East of the Boise Meridian, thence South six
22 miles to the Southeast corner of Section 32, same Township and
23 Range, thence West one-fourth of a mile, thence South five and
24 one-half miles, thence East one and one-half miles, thence
25 South one mile, more or less, to the South boundary line of
26 Fremont County, Idaho, thence in a Westerly direction on said
27 boundary line to where it intersects the section line between
28 sections 16 and 17, Township 7 North, Range 42 East, Boise
29 Meridian, thence North five miles, more or less, to a point
30 where said line intersects Falls River, said point being on
31 section line between Section 28 and 29, Township 8 North,
32 Range 42 East, Boise Meridian, thence in a Westerly direction
along the North Bank of the Falls River to a point where it
confluences with Henry's Fork of the Snake River where it
intersects the Section line between Sections 13 and 14, Township
8 North, Range 41 East of the Boise Meridian, thence North
two and one-fourth miles, more or less, to the Northwest
corner of Section 1, Township 8 North, Range 41 East of the
Boise Meridian, thence East one mile, more or less, to the
Southwest corner of Section 31, Township 9 North, Range 42
East of the Boise Meridian, thence North twenty-four miles,
more or less, to the Northeast corner of Section 1, Township
12 North, Range 42 East of the Boise Meridian, thence West

three miles, thence North ten miles; thence North and Easterly along Fremont County line to the Northernmost tip of Fremont County; thence South and Easterly to the Northeast corner of Section 2, Township 13 North, Range 45 East, Boise Meridian, thence South twenty-four miles along Fremont County line to the Southeast corner of Section 35, Township 10 North, Range 45 East, Boise Meridian, thence West three miles, more or less, to the point of beginning.
