

AN ORDINANCE TO AMEND ORDINANCE NO. 85-6 DEALING WITH CHILD DAY CARE LICENSING: TO DELETE ARTICLE 3, §9(d)&(f) SO THAT THE TERM "INVESTIGATION" NO LONGER INCLUDES F.B.I. CRIMINAL HISTORY AND FINGERPRINT CHECKS THROUGH THE F.B.I. AND CRIMINAL I.D. BUREAU; DELETING ARTICLE 4, §A, 3(d)(f) SO THAT F.B.I. CRIMINAL HISTORIES AND FINGERPRINTING CHECKS THROUGH THE F.B.I. AND CRIMINAL BUREAU ARE NO LONGER REQUIRED; ADDING A NEW ARTICLE 4, §E, REQUIRING ALL APPLICANTS TO BE CERTIFIED BY THE IDAHO DEPARTMENT OF HEALTH AND WELFARE; AND, PROVIDING THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, AS FOLLOWS:

That Ordinance No. 31, adopted by the Board of Commissioners of Fremont County, Idaho be amended as follows:

Section 1. That Article 3, §9(d)&(f) be deleted in their entirety, to read as follows:

"9. INVESTIGATION: Background record checks, including, but not limited to:

- (a) Local criminal,
- (b) Local non-criminal,
- (c) C.I.B. (Criminal Identification Bureau),
- ~~(d) F.B.I. criminal history,~~
- ~~(e)-(d) N.C.I.C. (National Crime Information Center),~~
- ~~(f) Fingerprint check through the F.B.I. and criminal identification bureau, and"~~

Section II. That Article 4 §A3(d)&(f) be deleted in their entirety to read as follows:

"3. Prior to the issuance of any licenses under this ordinance, the sheriff, deputy, or duly authorized representative shall conduct an investigation of the background of each applicant or other persons subject to the background check under this ordinance, in the following cases:

- (a) local criminal,
- (b) local non-criminal,
- (c) C.I.B. (Criminal Identification Bureau)-statewide,
- ~~(d) F.B.I. criminal history,~~
- (e) National crime information center,
- ~~(f) Fingerprint check through the F.B.I. and Criminal Identification Bureau, and"~~

Section III. That a new Article 4, §E be added to read as follows:

SECTION E.....CERTIFICATION

All Day Care and Group Care home providers and their employees shall attend and complete a training program provided by the Idaho Department of Health and Welfare. Each such provider and employee must be certified by the Idaho Department of Health and Welfare to completion of the program described above, prior to being issued a license pursuant to this Ordinance. Fees may be charged by the Idaho Department of Health and Welfare for the program provided, which fees shall be in addition to any other fees charged herein.

Section IV. This Ordinance shall be in full force and effect from and after its passage, all as provided by law.
