

ORDINANCE NO. 88-2
MOTOR VEHICLE REGISTRATION FEE ORDINANCE

AN ORDINANCE CHARGING AN ADMINISTRATION FEE OF TWO DOLLARS TO BE COLLECTED IN ADDITION TO EACH MOTOR VEHICLE REGISTRATION UNDER PROVISION § 31-870 IDAHO CODE, TO THE COUNTY TREASURER TO BE PLACED IN THE COUNTY CURRENT EXPENSE FUND.


WHEREAS, Fremont County, Idaho, the "County" herein, under and pursuant to the powers vested in it by Title 31, Chapter 8, § 31-870, Idaho Code, in order for the proper administration of motor vehicle licensure, the County deems it necessary to collect an additional fee pursuant to Idaho Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO:


An administrative fee of two dollars (\$2.00) shall be collected in addition to each motor vehicle registration tax or fee amount collected in the provisions of § 31-870, Idaho Code, and shall be paid to the County Treasurer when the vehicle is registered and be placed in the County current expense fund.

THIS ORDINANCE SHALL BE IN FULL FORCE AND IN EFFECT AUGUST 1, 1988 FROM AND AFTER THE DATE OF ITS PASSAGE, AND PUBLICATION AS PROVIDED BY LAW.
