AN ORDINANCE VACATING AND CLOSING A PORTION OF DAVIS STREET LYING SOUTH OF THE INDEPENDENT CANAL AND ADJACENT TO LOTS 1 & 2 OF BLOCK 7 AND LOT 2 OF BLOCK 8, ALSO ALL OF TOUT STREET LYING BETWEEN LOT 1 AND THE NORTH 1/2 OF LOT 4 OF BLOCK 7 AND LOT 2 AND THE NORTH 1/2 OF LOT 3, BLOCK 8, AND THE EAST 1/2 OF TOUT STREET ADJACENT TO LOT 6 AND SOUTH 1/2 OF LOT 3, BLOCK 8 OF THE EGIN TOWNSITE, FREMONT COUNTY, IDAHO, AS PER THE RECORDED PLAT THEREOF.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO:

SECTION I: That it is deemed expedient for the public good that the following described platted street of the County of Fremont, Idaho, to-wit:

All that portion of Davis Street lying South of the Independent Canal and adjacent to Lots 1 and 2 of Block 7 and Lot 2 of Block 8, also all of Tout Street lying between Lot 1 and the North 1/2 of Lot 4 of Block 7 and Lot 2 and the North 1/2 of Lot 3, Block 8, and the East 1/2 of Tout Street adjacent to Lot 6 and South 1/2 of Lot 3, Block 8 of the Egin Townsite, Fremont County, Idaho, as per the recorded plat thereof.

be, and the same is hereby vacated, closed and discontinued and the Fremont County Commissioners deem it in the best interests of the adjoining properties that a portion of the street so vacated and closed revert to the owner of the adjacent real estate, which owner is Tom Herron, to-wit:

all that portion of Davis Street lying South of the Independent Canal and adjacent to Lots 1 and 2 of Block 7 and Lot 2 of Block 8, also all of Tout Street lying between Lot 1 and the North 1/2 of Lot 4 of Block 7 and Lot 2 and the North 1/2 of Lot 3, Block 8, and the East 1/2 of Tout Street adjacent to Lot 6 and South 1/2 of Lot 3, Block 8 of the Egin Townsite, Fremont County, Idaho.

However, the rights of way, easement and franchise rights of any lot owners, of Fremont County, or of any public utility shall

not be impaired thereby and Fremont County reserves rights of way and easements under, over and across said vacated premises for County purposes.

SECTION II: That the said street so vacated is not necessary for the use as a street of the County of Fremont, Idaho, and is not required for any county purposes other than for possible future rights of way of easement for county utilities or other county purposes.

SECTION III: This ordinance shall take effect and be in full force and effect from and after its passage, approval and due publication as provided by law.
