

NEWDALE CITY ORDINANCE NO. 2003-01FREMONT COUNTY ORDINANCE NO. 2003-13

AN ORDINANCE ESTABLISHING AN AREA OF CITY IMPACT IN THE UNINCORPORATED PORTION OF FREMONT COUNTY SURROUNDING THE CITY OF NEWDALE, IDAHO; ADOPTING AN OFFICIAL MAP OF THAT AREA OF CITY IMPACT; AND, ESTABLISHING AN EFFECTIVE DATE.

BE IT HEREBY ORDAINED BY THE GOVERNING BOARDS OF THE CITY OF NEWDALE AND THE COUNTY OF FREMONT, as follows:

1. Newdale Area of City Impact Boundaries. An area of city impact for the City of Newdale is established within the boundaries of Fremont County as illustrated on the official area of impact map, attached hereto as Exhibit A with an accompanying legal description, which map is hereby made a part of this ordinance.

2. Effective Date. This ordinance shall be in full force and effect, from and after its passage, all as provided by law.

**Newdale, Idaho
Fremont County Impact Zone Boundary**

The following description defines the impact zone for the City of Newdale, Idaho within the confines of Fremont County, Idaho.

Beginning at the north 1/4 corner of section 2, Township 7 North, Range 41 East of the Boise Meridian;

Thence West along the section line and within the right-of-way of Idaho Highway 33 a distance of 8,220 feet, more or less, to a point approximately 300 feet west of the intersection of Fremont County 2700 East and Idaho Highway 33;

Thence North, paralleling 2700 East, 5,580 feet, more or less, to a point 300 feet west and 200 feet north of the intersection of 2700 East and 100 North;

Thence East, paralleling 100 North, 8,220 feet, more or less, to a point;

Thence South 5,580 feet, more or less, to the point of beginning.

Area encompasses 897 acres, more or less (does not include area within the present city limits of Newdale).
