ORDINANCE NO. 2009-02

AN ORDINANCE PERTAINING TO THE DISPOSAL OF REFUSE WITHIN THE COUNTY OF FREMONT, IDAHO; SETTING FORTH THE DEFINITIONS OF GARBAGE AND TRASH; PROVIDING VEHICLE REGULATIONS; LISTING CHARGES FOR UNCOVERED LOADS; STATING VIOLATIONS; PROVIDING THE EFFECTIVE DATE.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF FREMONT COUNTY, IDAHO, AS FOLLOWS:

SECTION 1. DEFINITIONS:

(A) GARBAGE: Shall mean:

Wastes from preparation, cooking and consumption of food, market refuse, waste from handling, storage and sale of produce, any and all rejected waste food, meat vegetable fruit, offal, swill and carrion, and any other like material from any source.

(B) TRASH: Shall mean:

(a) combustible: paper, cartons, boxes, barrels, wood and excelsior, trees trimmings, yard trimmings, wood furniture and bedding.

(b) non-combustible: metals, tin cans, metal furniture, dirt, small quantities of rock and pieces of concrete, glass crockery and other mineral refuse.

(c) ashes: residue from fires used for cooking and heating buildings or from fires in a trash burner.

(d) street rubbish: street sweepings, dirt, leaves, grass clippings, catch-basin dirt, contents of litter receptacles.

(e) dead animals or fowl; this shall include both domestic and wild animals and fowl.

SECTION 2: VEHICLE REGULATIONS:

Any vehicle used for the collection and removal of garbage, rubbish or trash shall be so equipped as to prevent the escape or spilling of any of the contents therefrom. Garbage or trash contained in bags will be accepted as covered.

SECTION 3: CHARGES FOR UNCOVERED LOADS:

This Ordinance will be implemented in the following manner:

A sign will be installed at the front gate of each Fremont County Landfill one (1) month prior to the implementation of the fee schedule. The sign will state that thirty (30) days from the posted date, a fee schedule will be implemented.

The following fees must be paid before the uncovered load will be allowed to unload at any Fremont County Landfill.

From the date the sign is posted to thirty (30) days thereafter: No fee.

From thirty (30) days to sixty (60) days after the posting of the sign: \$10.00.

From sixty (60) days to ninety (90) days after the posting of the sign: \$20.00.

Proceeds for uncovered loads shall be retained by the Fremont County Landfill.

SECTION 4: VIOLATIONS:

Failure to pay the fee will result in the vehicle being turned away. If the vehicle is turned away and is caught dumping the load on the side of the road, the owner can be charged with misdemeanor Placing Debris on Public or Private Property, Idaho Code ' 18-7031, a misdemeanor; which is punishable by imprisonment in a county jail not exceeding six (6) months, or by a fine not exceeding one thousand (\$1,000), or both; and public service of not less than eight (8) hours and not more than forty (40) hours; and will have his permission to use Fremont County landfill sites revoked.

SECTION 5: EFFECTIVE DATE:

This ordinance shall be in full force and effect upon publication.


