ORDINANCE NO. 2014 - 01

AN ORDINANCE REPEALING ORDINANCE 2005 – 06, ALLOWING DAY USE ONLY AND PROHIBITING FIRES AND OVERNIGHT CAMPING AND PARKING AT FREMONT COUNTY OWNED/MANAGED FISHING ACCESS SITES; DECLARING THAT A VIOLATION IS AN INFRACTION, AND PROVIDING PENALTIES THEREFORE; AND DECLARING THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, AS FOLLOWS:


1. **Repeal.** Ordinance 2005 – 06 is hereby repealed in its entirety and of no further force or effect.
2. **Ora Fishing Access.** The Ora Fishing Access site, located two miles West of Ashton is for day use only. No fires, overnight camping, or overnight parking is permitted.
3. **Vernon Fishing Access.** The Vernon Fishing Access site, located six miles West of Ashton, is for day use only. No fires, overnight camping, or overnight parking is permitted.
4. **Stone Bridge Fishing Access.** The Stone Bride Fishing Access site, located nine miles Northeast of Ashton if for day use only. No fires, overnight camping, or overnight parking is permitted.
5. **Fun Farm Fishing Access.** The Fun Farm Fishing Access site, located three miles Northeast of St. Anthony, is for day use only. No fires, overnight camping, or overnight parking is permitted.
6. **Jump Off Canyon.** The Jump Off Canyon Fishing Access site, located three miles Northeast of Ashton, is for day use only. No fires, overnight camping, or overnight parking is permitted.

7. **Marysville Fishing Access.** The Marysville Fishing Access site, located four miles Northeast of Ashton, is for day use only. No fires, overnight camping, or overnight parking is permitted.
8. **Fremont County Boat Docks.** The Fremont County Boat Docks, located three miles Northwest of Ashton is for day use only. Fires restricted to existing fire pits only. No overnight camping or overnight parking is permitted.
9. **Violations.** Violations of this ordinance shall be an infraction, punishable by a fine of \$75.00.
10. **Effective Date.** This ordinance shall be in full force and effect upon publication.
