**RESOLUTION 2010-~~06~~07**

A RESOLUTION ORDERING DESTRUCTION OF PERMANENT COUNTY RECORDS MAINTAINED BY THE FREMONT COUNTY PROSECUTING ATTORNEY'S OFFICE.

WHEREAS, Joette C. Lookabaugh, Fremont County Prosecutor for Fremont County, Idaho, has conducted an audit of certain records being retained by the Fremont County Prosecutor's Office;

WHEREAS, the audit identified a detailed list of approximately three (3) years of criminal records, 1998 through 2000, classified as "permanent" as defined by the provisions of Idaho Code section 31-871;

WHEREAS, in accordance with Idaho Code Section 31-31-871(2)(a) all permanent records shall be kept for not less that ten (10) years after the date of issuance or completion of the matter contained with in the record; and

WHEREAS, the board of county commissioners of Fremont County, Idaho believes it is in the best interests of the county to destroy the above-identified records.

NOW THEREFORE, BE IT RESOLVED that the detailed list of permanent records, attached hereto and incorporated herein by this reference as Exhibit "A", currently being retained by the Fremont County, Idaho, Prosecuting Attorney's Office be destroyed in accordance with the requirements of Idaho Code section 31-871.



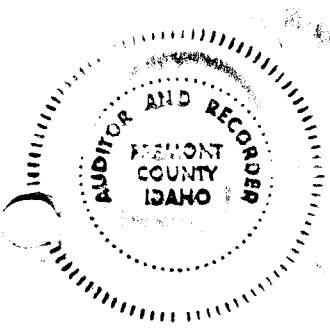
