

RESOLUTION NO. 2011- 18

A RESOLUTION OF FREMONT COUNTY, IDAHO, DETERMINING THE NECESSITY TO CLOSE THE FUN FARM BRIDGE, TO BE CLOSED TO ALL MOTORIZED, ANIMAL, OR HUMAN TRAFFIC, DUE TO UNSAFE CONDITIONS OF THE BRIDGE, TO BE IN EFFECT UNTIL COMPLETION OF REPAIRS TO THE BRIDGE OR OTHERWISE TERMINATED BY RESOLUTION OF THE FREMONT COUNTY BOARD OF COMMISSIONERS.

WHEREAS, Idaho Code § 31-801 grants general powers and duties, subject to the restrictions of law, to the boards of county commissioners in their respective counties; and

WHEREAS, Idaho Code § 31-828 grants the board of commissioners authority "to do and perform all other acts . . . which may be necessary to the full discharge of the duties of the chief executive authority of the county government"; and

WHEREAS, the Fremont County Public Works Administrator has determined that deterioration of the road surface and worsening of the structure of the bridge has made the bridge unsafe, making it necessary to close the Fun Farm Bridge; and

WHEREAS, repair crews will perform work to repair the bridge under the direction of the Fremont County Public Works Department; and

WHEREAS, the Fun Farm Bridge needs to be closed in order to protect the safety of Fremont County citizens, and allow the repairs to the bridge;

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, THE BOARD OF COUNTY COMMISSIONERS HEREBY DECLARES THAT THE FUN FARM BRIDGE IS IN AN UNSAFE CONDITION AND HEREBY ORDERS THAT THE FUN FARM BRIDGE BE CLOSED TO ALL MOTORIZED TRAFFIC AND ANY POTENTIAL ANIMAL TRAFFIC. THE BOARD FURTHER ORDERS THAT THIS BRIDGE CLOSURE SHALL REMAIN IN EFFECT UNTIL REPAIRS ARE COMPLETED OR OTHERWISE TERMINATED BY RESOLUTION OF THE BOARD.


This resolution shall be in full force and effect immediately after its passage.
