

RESOLUTION NO. 2012- 07 <sup>2011</sup>

A RESOLUTION OF FREMONT COUNTY, IDAHO, INCREASING THE COUNTY LANDFILL FEES BY AN ADDITIONAL THIRTEEN PERCENT (13%) TO CONSTRUCT A TRANSFER STATION AT THE ST. ANTHONY LANDFILL.

WHEREAS, Idaho Code provides that a county commission may impose and collect fees for services provided by the county that would otherwise be funded by ad valorem tax revenues; and

WHEREAS, Idaho Code requires that such fees imposed must be reasonably related to the service provided and may not exceed the actual cost of the service provided; and

WHEREAS, Idaho Code specifically grants a county commission the authority to establish a solid waste fee to be certified and collected in the same manner as property taxes; and

WHEREAS, Fremont County has established and currently collects solid waste fees within the county to cover the costs and expenses associated with the collection, storage and processing of solid waste within Fremont County; and

WHEREAS, the construction of a transfer station at the St. Anthony Landfill has become necessary; and

WHEREAS, increasing the current landfill and solid waste fees by 13% is reasonably necessary to assist Fremont County to meet, but not exceed its costs and expenses associated with constructing a transfer station at the St. Anthony Landfill, to aid in the collection, storage and processing of solid waste within Fremont County; and

WHEREAS, this increase is over and above the 11.5% increase approved by the Board of Commissioners on August 29, 2011.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, THAT ALL LANDFILL OR SOLID WASTE FEES ESTABLISHED IN FREMONT COUNTY BE INCREASED BY AN ADDITIONAL THIRTEEN PERCENT (13%), TO BE COLLECTED BY THE FREMONT COUNTY TREASURER ACCORDING TO LAW. SUCH FEES SHALL BE KEPT ON RECORD AND SHALL BE MADE AVAILABLE TO THE PUBLIC AT THE OFFICE OF THE FREMONT COUNTY TREASURER.


This resolution shall be in full force and effect commencing on October 14, 2011.
