
WHEREAS, the audit identifies a detailed list of records shown in Exhibit "A" as defined by the provisions of Idaho Code section 31-871;

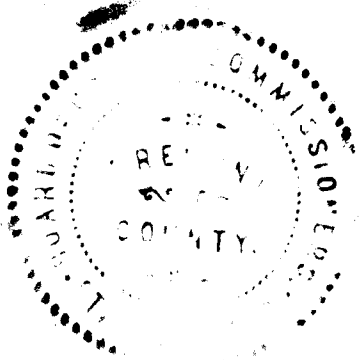
WHEREAS, the board of county commissioners of Fremont County, Idaho believes it is in the best interests of the county to destroy the above-identified records.


