

RESOLUTION NO. 2012- 20

A RESOLUTION OF FREMONT COUNTY, IDAHO, ESTABLISHING THAT THE ELECTED PROSECUTING ATTORNEY OF FREMONT COUNTY HAS BEEN SINCE OCTOBER 1, 2005, AND SHALL CONTINUE TO BE A FULL-TIME POSITION; THAT THE PROSECUTING ATTORNEY MAY CONTRACT WITH CITIES WITHIN THE COUNTY TO PROSECUTE MATTERS ONLY WITH THE UNANIMOUS APPROVAL OF THE BOARD OF COUNTY COMMISSIONERS; AND THE PROSECUTING ATTORNEY SHALL NOT USE COUNTY RESOURCES, STAFF OR OFFICE SPACE FOR NON-COUNTY OR PRIVATE PURPOSES.

WHEREAS, the Board of County Commissioners have the duty pursuant to Idaho Code § 31-802 to supervise the official conduct of all county officers; and

WHEREAS, at the request of the Prosecuting Attorney on or about October 1, 2005, the position of Fremont County Prosecuting Attorney was converted from a part-time position to a full-time position; and

WHEREAS, Fremont County provides all staffing equipment and office space for the Prosecuting Attorney; and

WHEREAS, the elected Fremont County Prosecuting Attorney has continued to be a full-time position from October 1, 2005 to the present; and

WHEREAS, the salary of the Fremont County Prosecuting Attorney as set by the Board of County Commissioners has been set since 2006 to reflect the fact that the Prosecuting Attorney is a full-time position.


NOW THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Fremont County, State of Idaho that the elected Prosecuting Attorney of Fremont County has been since October 1, 2005, and shall continue to be a full-time position.

BE IT FURTHER RESOLVED, that the Prosecuting Attorney may contract with any city within the county to prosecute non-conflicting misdemeanors and infractions only with the unanimous approval of the Board of County Commissioners as provided by Idaho Code § 31-3113.

BE IT FURTHER RESOLVED, that the Prosecuting Attorney shall not use county resources, staff or office space for any non-county or private purposes.
