RESOLUTION 2012-4

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, DESIGNATING IDAHO ASSOCIATION OF COUNTIES AS FREMONT COUNTY'S REPRESENTATIVE TO RESOLVE WHETHER THROUGH NEGOTIATION AND/OR LITIGATION THE ISSUE OF WHETHER TRACFONE AND OTHER TELECOMMUNICATION COMPANIES ARE RESPONSIBLE TO COLLECT AND DISTRIBUTE THE EMERGENCY COMMUNICATIONS FEE TO EACH COUNTY AS PROVIDED IN THE IDAHO EMERGENCY COMMUNICATIONS ACT AND WHETHER THROUGH NEGOTIATION AND/OR LITIGATION ANY COMPENSATION OWED FROM THOSE TELECOMMUNICATION COMPANIES FOR THEIR FAILURE TO COLLECT AND REMIT THE 911 FEE PROVIDE BY FOR THAT ACT.

WHEREAS, Fremont County wishes to designate a representative from the Idaho Association of Counties resolve through negotiation and/or litigation the issue of whether TracFone and other telecommunication companies are responsible to collect and distribute the emergency communications fee to each county as provided in the Idaho Emergency Communications Act; and

WHEREAS, Fremont County wishes to designate a representative from the Idaho Association of County resolve through negotiation and/or litigation any compensation owed from those telecommunication companies for their failure to collect and remit the 911 fee provide for by the Idaho Emergency Communications Act; and

WHEREAS, representatives from the Idaho Association of Counties have agreed to represent Fremont County in resolving through negotiation and/or litigation the violations of the Idaho Emergency Communications Act.

THEREFORE, be it resolved that Fremont County is in full support of designating and does hereby designate Idaho Association of Counties as the county's representative to resolve whether through negotiation and/or litigation the issue of whether TracFone and other telecommunication companies are responsible to collect and distribute the emergency communications fee to each county as provided in the Idaho Emergency Communications Act.




