WHEREAS, the audit identifies a detailed list of records shown in Exhibit "A" as defined by the provisions of Idaho Code section 31-871;

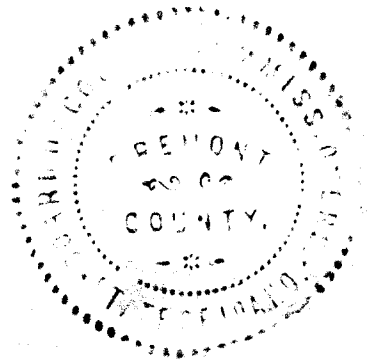
WHEREAS, the Board of County Commissioners of Fremont County, Idaho believes it is in the best interest of the county to destroy the above-identified records.
