

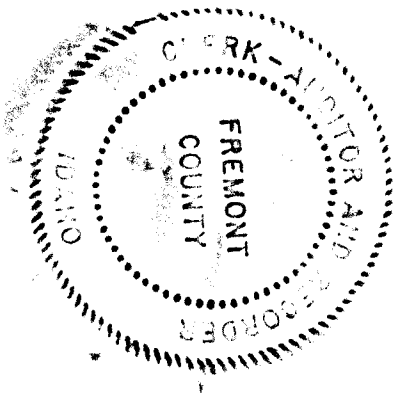
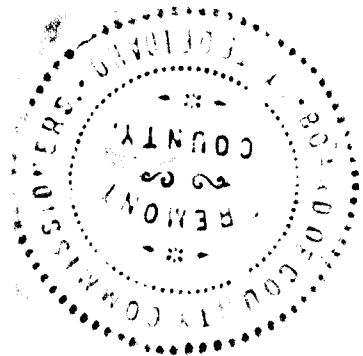
The budget for fiscal year 2015-2016 as presented on September 8, 2015, by the Fremont
