RESOLUTION NO. 2017- 02

A RESOLUTION OF FREMONT COUNTY, IDAHO, AMENDING THE CURRENT LANDFILL FEES, AND REPEALING ALL PREVIOUS RESOLUTIONS THAT ARE INCONSISTENT WITH THIS RESOLUTION, EFFECTIVE THE 1<sup>ST</sup> DAY OF OCTOBER, 2016.

WHEREAS, Idaho Code provides that a county commissioner may impose and collect fees for services provided by the county that would otherwise be funded by the valorem tax revenues; and

WHEREAS, Idaho Code required that such fees imposed must be reasonably related to the service provided and may not exceed the actual cost of the services; and

WHEREAS, Idaho Code specifically grants a county commission the authority to establish a solid waste fee to be certified and collected in the same manner as property taxes; and

WHEREAS, the Board of County Commissioners of Fremont County, Idaho, has determined that it is the best interest of the public to amend the current landfill fees to the following:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF FREMONT COUNTY, IDAHO, THAT ALL LANDFILL OR SOLID WASTE FEES ESTABLISHED IN FREMONT COUNTY BE APPORTIONED ACCORDING THE TABLE ABOVE, TO BE COLLECTED BY THE FREMONT COUNTY TREASURER ACCORDING TO LAW. SUCH FEES SHALL BE KEPT ON RECORD AND SHALL BE MADE AVAILABLE TO THE PUBLIC AT THE OFFICE OF THE FREMONT COUNTY TREASURER.


This resolution shall be in full force and effect on the 1<sup>st</sup> day of October, 2016.
