

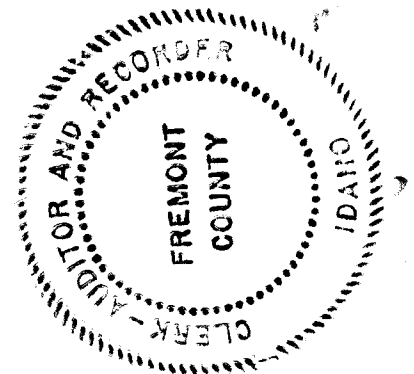
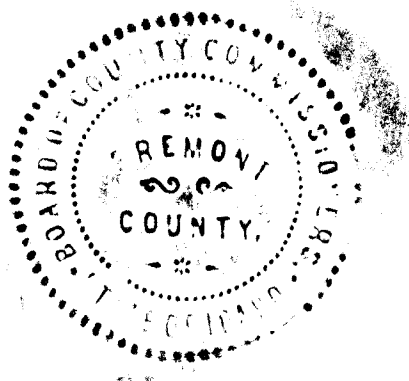
WHEREAS, the Board of County Commissioners of Fremont County, Idaho believes it is in the best interest of the county to destroy the above-identified records.


