RESOLUTION NO. 2017- 67

A RESOLUTION OF FREMONT COUNTY, IDAHO, INCREASING THE FREMONT COUNTY AMBULANCE FEES.

WHEREAS, Idaho Code provides that a county commission may impose and collect fees for services by the county that would otherwise be funded by ad valorem tax revenues; and

WHEREAS, Idaho Code requires that such fees imposed must be reasonably related to the services provided and may not exceed the actual cost of the services provided; and

WHEREAS, Idaho Code specifically grants a county commission the authority to adopt a schedule of fees to be charged for the use of the ambulance services; and

WHEREAS, Fremont County has established and currently collects ambulance fees within the county to cover the costs and expenses associated with the ambulance services provided within Fremont County; and

WHEREAS, adopting the Patient Billing Worksheet (Exhibit A) is reasonably necessary to assist Fremont County to meet, but not exceed its costs and expenses in providing ambulance services within Fremont County.

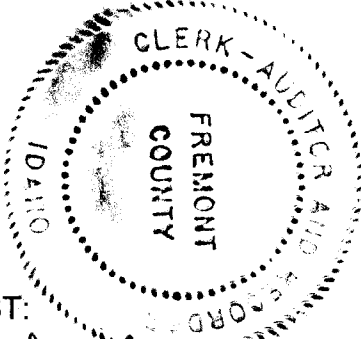

This resolution shall be in full force and effect on the 30th day of January, 2017.



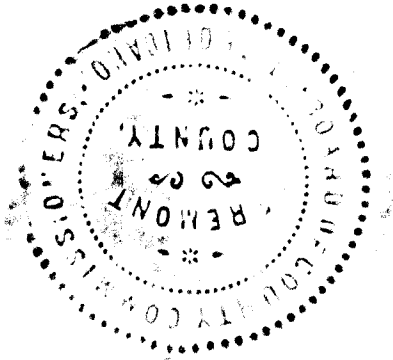
