RESOLUTION 2017- 08

A RESOLUTION AUTHORIZING THE DESTRUCTION OF THE HARD COPIES OF RECORDS, CLASSIFIED AS PERMANENT RECORDS, MAINTAINED BY THE FREMONT COUNTY PROSECUTING ATTORNEY'S OFFICE.

WHEREAS, the Deputy Prosecuting Attorney ("Deputy P.A.") for Fremont County has identified certain criminal records, the years of 2000; 2002; 2006; and 2007, classified as "permanent" as defined by the provisions of Idaho Code section 31-871;

WHEREAS, the Deputy P.A. has determined that said records maintained by the Prosecutor's Office have been scanned into Computer Arts, Inc. (CAI) for storage;

WHEREAS, the Deputy P.A. has determined that said documents are being backed up and retained by CAI;

WHEREAS, in accordance with Idaho Code Section 31-871(2)(a) all permanent records shall be kept for not less than ten (10) years after the date of issuance or completion of the matter contained with in the record;


WHEREAS, since the above detailed criminal records have been scanned and will be retained, there is no further need keep the hard copies of such;

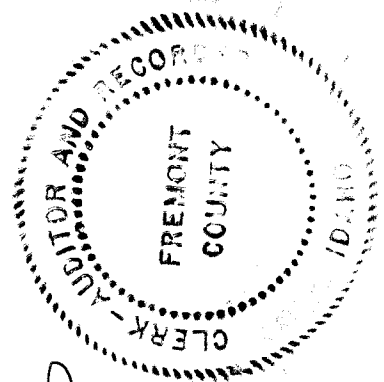
WHEREAS, the Board of County Commissioners of Fremont County, Idaho believes it is in the best interests of the county to destroy the above-identified records.



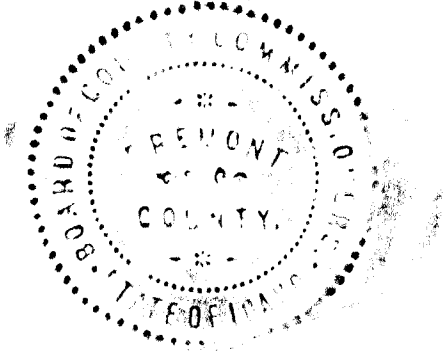
